Tube Butt Weld Ends

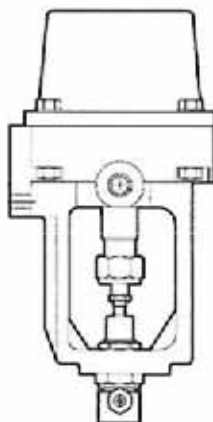


Butt Welded Female  
VCR Fitting Ends

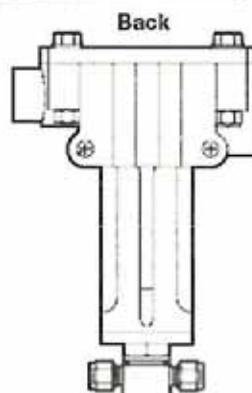

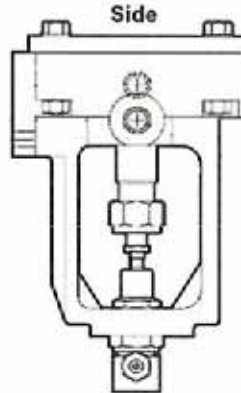

Normally Closed



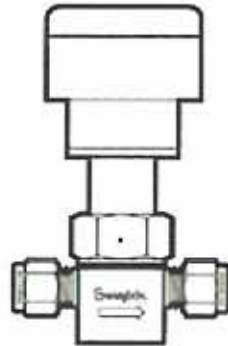
Normally Open and Double Acting
