This includes off-catalog product that can be assembled through designators, assemble to order ("ATO"), make to order ("MTO"), product produced by other means.

Description and Reason for Change

Product Name: Fluid Distribution Headers (FDH)

- The change helps Swagelok factory with stocking select to improve delivery time
- The change include
 - + FDH1 manifold: end caps and O-rings are no longer available. Instead, the ends of the manifold bodies will be threaded with ¾ in. female NPT. Alternative end connections are available by using adapter fittings.
 - + FDH2 manifold: the number of end cap configurations has been reduced. The alternative end connections can be provided using adapter fittings.

 - + SS-FDH1-CB-F4 (1 in. pipe, 2 sides 180 degrees apart, 6 outlets)
 - + SS-FDH1-CD-F4 (1 in. pipe, 2 sides 180 degrees apart, 10 outlets)
 - + SS-FDH2-CB-F8 (2 in. pipe, 2 sides 180 degrees apart, 6 outlets)
 - + SS-FDH2-CD-F8 (2 in. pipe, 2 sides 180 degrees apart, 10 outlets)
- b) The others: applied MOQ 10 pieces per item or paying a set-up charge instead of buying the MOQ
